MAHARASHTRA ZILLA PARISHADS AND PANCHAYAT SAMITIS ACT, 1961.

N.S. DSR. 4971/48781-S.—In exercise of the powers conferred by clauses (xxxvii) and (xxxix) of sub-section (2) of section 274 of the Maharashtra Zilla Parishads and Panchayat Samitis Act, 1961 (Mah. V of 1962), and of all other powers enabling it in that behalf, the Government of Maharashtra hereby makes the following rules further to amend the *Maharashtra Zilla Parishads District Services (Medical Attendance) Rules, 1971, the same having been previously published as required by sub-section (3) of the said section 274, namely :—

1. (1) These rules may be called the Maharashtra Zilla Parishads District Services (Medical Attendance) (Amendment) Rules, 1974.

*These rules were last amended by Government Notification, Rural Development Department, No. DSR. 4971/54910-S, dated the 15th April 1972, published at pages 451, and 452 of the Maharashtra Government Gazette, Extraordinary, Part IV-B, dated the 15th April 1972.

(2) They shall be deemed to have come into force on the 2nd day of August, 1973.

2. In the Maharashtra Zilla Parishads District Services (Medical Attendance) Rules, 1971, in rule 2,—

(a) in clause (b),—

(i) in sub-clause (i), the words "or the District Medical Officer" shall be *deleted*;

(ii) after sub-clause (iii), the following shall be *inserted*, namely :—

"(iv) in relation to all Parishad Servants,—

(a) the Dean, Government Dental College, and Hospital Nagpur ;

(b) the Dean, Government Dental College, Bombay ; and

(c) any Assistant Dean, Medical Superintendent, Superintendent, Resident Medical Officer, Junior Resident Medical Officer or Assistant Medical Officer who is in-charge of any hospital or dispensary, owned and maintained by a municipal corporation or a municipal council, constituted under any law for the time being in force in the State";

(iii) in Explanation 2, after the word "categories", the words and figures "specified in sub-clauses (i), (ii) and (iii)" shall be *inserted*;

(b) in clause (i), in sub-clause (i), the brackets and words "(v) the prior approval of the Authorised Medical Attendant)" shall be *deleted*.

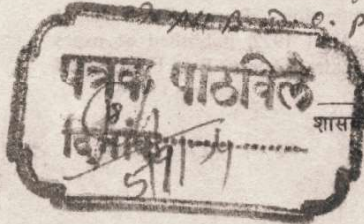
