MAHARASHTRA ZILLA PARISHADS AND PANCHAYAT SAMITIS ACT, 1961.

No. DSR. 4973/35017-III.—The following draft of rules further to amend the Maharashtra Zilla Parishads District Services (Medical Attendance) Rules, 1971 which the Government of Maharashtra proposes to make in exercise of the powers conferred by clauses (xxxvii) and (xxxix) of sub-section (2) of section 274 of the Maharashtra Zilla Parishads and Panchayat Samitis Act, 1961 (Mah. V of 1962), and of all other powers enabling it in that behalf, is published as required by sub-section (3) of the said section 274 for the information of all persons likely to be affected thereby; and notice is hereby given that the said draft will be taken into consideration by the Government of Maharashtra after the 8th day of March 1976.

DRAFT RULES

1. These rules may be called the Maharashtra Zilla Parishads District Services (Medical Attendance) (Amendment) Rules, 1976.

2. For rule 24 of the Maharashtra Zilla Parishad District Services (Medical Attendance) Rules, 1971, the following shall be substituted, namely :—

'24. *Concessions for Parishad servants reaffected with T. B.*—(1) The concessions granted to a *Parishad* servant suffering from tuberculosis shall be granted to the *Parishad* servant for second time in the ordinary course and for third time with previous approval of the Divisional Commissioner, after producing the necessary certificate from the Authorised Medical Attendant, that the *Parishad* servant has scrupulously followed the provisions in rule 17 and that it is still necessary to grant him T. B. concession for the third time.

(2) No T. B. concession shall be granted to a *Parishad* servant for the fourth time, and where a *Parishad* servant asks for such concession for the fourth time, the Zilla Parishad shall require such servant to appear before the Medical Board, which may advise the *Parishad* whether or not the *Parishad* servant should be invalidated and barred from further service under the *Parishad*."
