## NOTIFICATION

No. CDR-1011/C.R.-109/11- In exercise of the powers conferred by the proviso to article 309 of the Constitution of India, the Governor of Maharashtra is hereby pleased to make the following rules further to amend the Maharashtra Civil Services (Discipline and Appeal) Rules, 1979, namely :-

1. These rules may be called the Maharashtra Civil Services (Discipline and Appeal) Rules, 2011.
2. In rule 4 of the Maharashtra Civil Services (Discipline and Appeal) Rules, 1979, in sub-rule (5), after clause (c), the following proviso shall be added, namely:-  
“Provided that, where a criminal offence is registered against a Government servant, the recommendation of the Suspension Review Committee constituted by the Government in this behalf, shall be obtained by the authority which has made or is deemed to have made the suspension order or by any authority to which that authority is subordinate, before revoking or modifying the order of suspension of such Government servant.”


