Resolution: - A question has arisen whether the orders contained
in Government Circular, General Administration Department, NO. SRV./
1074-D, dated 21st September 1974, are applicable to the cases of
Inter District or/and Inter Divisional transfers of married women
employees in Revenue Department and if so, whether the orders
contained in Government Circular Memorandum, Revenue Department, NO.
3249/51, dated 23th February 1952, are to be treated as cancelled.

2. In order to ensure the moral safety of the married
women employees, Government has accepted the principle that they
should not be separated from their husbands. It has therefore, been
decided by Government that a married women employee should be
posted, as far as possible, to the place of her husband. It is not
necessary that the husband be in Government service, for this

purpose.

If the husband is transferable, it would be desira-
ble to transfer his wife also provided such transfer is administrat-
ively feasible. For facilitating such transfers provision has been
made in Government Circular, General Administration Department NO. SRV./
1072-D, dated 30th November 1972, for inter department/inter
district transfers from Government service to Zilla Parishads/

Municipalities and vice versa. A provision has also been made in Government Circular, General Administration Department NO.SRV./1074/D, dated 4th March 1975, for transfers of married women employees from mofussil to the offices in Greater Bombay to the ~~municipal~~ ^{ministerial} posts which are within the purview of the Maharashtra Public Service Commission. Seniority of women employees, on transfers, will be governed by the orders contained in Government Circular, General Administration Department NO.SRV./1974/D dated 21st September 1974.

3. The orders contained in Government Circular, Memorandum, Revenue Department, NO.3239/51, dated 23th February 1952 are of general nature in respect of Government employees who apply for transfer on personal grounds. These orders therefore, stand modified to the extent of orders quoted above, in respect of married women employees.

4. These orders issue in consultation with the General Administration vide its un-official reference dated 13th August 1975.
