

No SANKIRNA /12002/CR 225/PH-4 :- In exercise of the powers conferred by sub-section (2) and (3) of section 1 of the Bombay Nursing Homes Registration Act, 1949 (Bom XV of 1949), the Government of Maharashtra hereby :-

(1) directs that the provisions of section 2 to 18 of the said Act, shall extend to the areas falling within the limits of the Municipal Corporations of the Cities of Ulhasnagar, Akola, Sangli-Miraj-Kupwad, Malegaon, Nanded-Waghala, Bhiwandi-Nizampur and Mira-Bhayander, constituted under the provisions of section 3 of the Bombay Provincial Municipal Corporations Act, 1949 (Bom LIX of 1949); and

(2) appoints the 15th June, 2003 to be date on which the said provisions shall come into force in the said areas, to which it has been so extended
